I. CALL TO ORDER

The Regular Meeting of the Wasilla City Council was held on Monday, May 14, 2012, at the Wasilla City Council Chambers, Wasilla, Alaska. Mayor Verne E. Rupright called the meeting to order at 6 p.m.

II. ROLL CALL

Mayor Rupright noted that Mr. Brandon Wall, Seat F, was absent and excused unless there was any objection. There was no objection noted.

A. Parks and Recreation Commission

Mr. Combs:

- provided an updated on parks and recreation efforts at the City Parks and the Curtis D. Menard Memorial Sports Center;
- commented on Wasilla Clean Up Days; and
- noted that the Parks and Recreation Commission passed a resolution in support of a community garden at their May 9, 2012, Regular Meeting.

VOTE: The motion to adopt Ordinance Serial No. 12-14 passed unanimously.

2. **Ordinance Serial No. 12-15:** Amending the FY2012 budget by appropriating \$88,000 from the General Fund, Fund Balance to the Capital Fund's Land Acquisition Account to Purchase Lots 10 and 11, Block 6, Wasilla Townsite and authorizing the Mayor to execute the Land Purchase and Sale Agreement for said purchase.

Mayor Rupright opened the public hearing on Ordinance Serial No. 12-15. There being no one present who wished to speak, Mayor Rupright closed the public hearing. Mr. Giddings provided a staff report.

MOTION: Council Member Sullivan-Leonard moved to adopt Ordinance Serial No. 12-15.

Discussion moved to the Council.

VOTE: The motion to adopt Ordinance Serial No. 12-15 passed unanimously.

- stated that he is in favor of a five lane highway and not in favor of a four lane divided highway; and
- noted that he would like a stop light at Lamont Way and not at the proposed Stanley Road.

Ms. Mary Kvalheim:

- requested that the Mayor's Minutes be put on the City's website ; and
- thanked Ms. Joan Matthews for passing out garbage bags to their entire subdivision.

Mr. Tom Stoelting and Ms. Arlene Stoelting:

- spoke regarding the Parks Highway expansion; and
- stated that they are in favor of a five lane highway and not in favor of a four lane divided highway.

Ms. Anne Kilkenny:

- thanked the City Council for supporting the Youth Court;
- spoke in favor of AM No. 12-19, regarding the renewal of the contract with Denali Law;
- spoke regarding discouraging the use of plastic bags in the City of Wasilla; and
- opined that the City Council should pass an ordinance which requires businesses to charge for the use of plastic bags.

C. **AM No. 12-21**: Contract award to Alaska Snow Removal Services in the amount of \$95,000 for the Lake Lucile demonstration project to enhance water quality by reviving spring water feeding the lake using a suction dredge.

Deputy Mayor Holler noted that he had relatives who lived on Lake Lucille and added that it could be construed as a conflict of interest.

Mayor Rupright ruled that Deputy Mayor Holler did not have a conflict of interest.

MOTION: Council Member Woodruff moved to adopt AM No. 12-21.

Discussion moved to the Council.

VOTE: The motion to adopt AM No. 12-21 passed unanimously.

- spoke regarding the Parks Highway expansion;
- commented on the differing needs of the property owners along the highway; and
- pointed out the increased traffic during the summer months and opined that those needs should be addressed.

- reminded the Council that the next meeting is June 11, 2012; and
- asked for the Council to inform her if they would like to attend the Alaska Municipal League meeting in Bethel.

Mr. Payne:

- thanked the City Council for approving AM No. 12-19, approving the contract extension to Denali Law;
- complimented the Sports Center on the great job they did with hosting the Wrestling Championship; and
- spoke to a potential executive session that may be needed regarding matters that pertain to litigation.

XIV. COUNCIL COMMENTS

MOTION: Council Member Harris moved to direct the City Attorney to strike the section of City Code that allows a private citizen to bring an injunction against the City as it relates to speech.

Discussion ensued.

Council Member Harris spoke regarding the Parks Highway expansion.

Council Member Woodruff:

- spoke regarding WMC 2.04.040.A.2, regarding a council member's absence;
- requested that the Council be asked if someone is excused from their absence, instead of simply noting that the council member is absent at roll call;
- thanked the Youth Court staff and the citizens involved with the success of the Youth Court;
- thanked everyone who helped with Wasilla Clean Up Days;
- spoke in favor of supporting businesses to offer incentives for bringing their own bags and not using plastic bags;
- encouraged the City Council to listen to the audio CD distributed by the Mr. William Bruu;
- noted her displeasure with some of the comments that can be heard on the audio CD;
- thanked Mr. Payne for his services;
- commented on her use of the City's Attorney's time; and
- spoke regarding her concerns with the expansion of the Parks Highway.

Council Member Katkus:

- noted her pleasure with the City hosting the wrestling tournament at the Curtis D. Menard Memorial Sports Center;
- thanked the Parks and Recreation Commissioners for all the time they volunteered during Wasilla Clean Up Days;
- opined that the City needs annual events and commented on the need for an aviation show;
- noted her pleasure at the possible expansion of the Wasilla Public Library; and
- encouraged the business owners along the Parks Highway to be involved in the public process during the expansion phases.

Deputy Mayor Holler:

- addressed Chief Belden and expressed his concerns with the Code Compliance Officer's behavior with the public; and
- queried the status of the burnt building at the corner of Swanson Avenue and North Willow Street.

Mr. Giddings provided an update.

Council Member Sullivan-Leonard:

- commended the members of the public who participated in Wasilla Clean Up Days;
- informed the Council that she attended the Alaska Municipal League Board Meeting on Friday, May 11, 2012;
- provided highlights from the meeting and covered future items of discussion during the upcoming meeting in Bethel;

- spoke to the passing of Former Mayor Harold Newcomb.
