SUMMARY STATEMENT: In accordance with WMC 5.08.108, the City of Wasilla would like to procure generator diesel fuel in accordance with the Mat-Su Borough's contract with Crowley Petroleum. MSB awarded the contract to Crowley Petroleum on June 22, 2011, with an amendment dated, May 3, 2012 for a 1 year extension. MSB has allowed the City of Wasilla to piggy back on their contract. The rates for the fuel are \$.14 over OPIS. This is a fair and reasonable rate, had we went out to market on our own the rates would have been higher due to our consumption is much lower than the MSB's. Having the ability to utilize their contract will save the City money.
