**SUMMARY STATEMENT:** Resolution Serial No. 12-22 designates sewage treatment plant improvements as the number one local funding priority for the Alaska, Department of Environmental Conservation fiscal year 2014 municipal water and sewer grant program. A resolution is needed to support the grant request. The City has \$500,000 in state legislative funding that will be used to match the state grant request for this project. This project is the number one priority for the water/sewer utility in terms of compliance with regulatory authorities. This project will modify the existing aerated lagoons to increase treatment efficiency and expand the drainfield. The grant request will be in the amount of \$2.4 million.
