#### I. CALL TO ORDER

The City Clerk explained that voting on the issue was closed and that her vote was recorded in the negative.]

# XII. AUDIENCE COMMENTS

Ms. Julia Ede:

- explained the preexisting inadequacies of the Wasilla Public Library;
- spoke to the efforts of the Library Steering Committee to bring forth the needed documentation; and
- stressed the need for a new library.

Ms. Pam Ockerlander, Friends of Wasilla Public Library:

- invited Council Member Katkus to speak with Matanuska-Susitna Borough representatives and invite them to share the costs of a new library with the City;
- opined that a library is a need of the city, not a want; and
- invited the council members to speak with any of the committee members regarding the needs of the library.

Ms. Anne Killkenny:

- stressed that the need for a new library is not a new issue; and
- encouraged the City Council members to continue their discussions regarding the specifics for a new library and to find a way to fund the library.

Ms. Margaret Heaven:

- requested that the City not postpone this ordinance for very long; and
- spoke regarding the importance of the library to the City and its citizens.

Ms. Diana Straub spoke regarding the importance of asking the voters if they are willing to pay for a new library and to not make assumptions for the voters.

## XIII. MAYOR, CLERK AND ATTORNEY COMMENTS

Ms. Smithers:

- spoke to an error on page 5 of the packet;
- stated that there were two references to "City of Wasilla" which would be changed to "Wasilla"; and
- asked for direction from the Council regarding the three special meetings that are currently calendared for the City Council regarding proposed Ordinance Serial No. 12-23.

Discussion ensued regarding whether the meetings should remain on the calendar.

- MOTION: Council Member Sullivan-Leonard moved to cancel all the special meetings scheduled for July 2012.
- VOTE: The motion passed with Council Members Harris, Katkus, Sullivan Leonard and Wall in favor and Council Member Woodruff in opposition.

Ms. Smithers clarified that the special meetings scheduled for July 16, 23 and 30, 2012, would be cancelled.

## XIV. COUNCIL COMMENTS

Council Member Woodruff

- spoke regarding previous discussions with the Borough that have taken place regarding the library;
- commented on the need to make informed decisions;
- spoke regarding new full time employees being added to City staff; and
- asked for the upcoming capital improvement project list to include adding restroom facilities on the turf court at the Curtis D. Menard Memorial Sports Center.

Council Member Katkus spoke regarding the consequences of being a leader and the associated responsibility.

Council Member Sullivan-Leonard:

- spoke regarding the need to make informed decisions;
- commented on quality of life issues;
- commended the Library Needs Committee and the Friends Wasilla Public Library for the work they have done towards obtaining a new library; and
- spoke regarding Resolution Serial No. 12-20, regarding the Coastal Zone Management Plan.

Council Member Harris:

- commended the Library Needs Committee and the Friends Wasilla Public Library for the work they have done towards obtaining a new library;
- commented on taxation; and
- spoke in favor of Resolution Serial No. 12-20, regarding the Coastal Zone Management Plan.

Council Member Wall:

- spoke in favor a new library;
- spoke regarding the financial situations the City will be facing in 2014; and
- asked the attorney for a clear opinion regarding how the City of Wasilla can raise the sales tax, be it by a vote of the people or by council.
