**SUMMARY STATEMENT:** On July 31, 2012 the Storage Area Network system went down due to some hardware and software issues. When required to bring HP technicians in to assist, the City discovered that the warranty and maintenance support had expired, which brought forth this Ordinance to regain support from HP. In referencing the below Email received from Mike Thomas, the City's assigned Tekmate Technician under contract, one can appreciate the importance of the HP servers, SAN switch and the software that supports this environment.

From Mike Thomas – August 16, 2012:

The Storage Area Network serves as the central storage location for the Police Departments individual and department electronic documents; SIRE Electronic Records management documents; backup location for all former employees e-mails/electronic documents (that have not yet reached their destruction date; and planned location for all other departmental electronic documents in order to have a central location for all city records.

We also have our blade servers and SIRE Production, SIRE Test, Domain Controller, and the planned upgrade for Exchange Server 2010.

The chassis currently houses all the blade servers (8) and houses the hardware that controls the Storage Area Network (setup, maintenance, fixes, and allocation of storage space). Among the blade servers are the SIRE Production, SIRE Test, Police Department Domain Controller, Share point Server, and the planned Exchange 2010 server.

The recurring cost will not only protect the city in the event of hardware failure (over 15 different pieces with a replacement value of each piece being anywhere from 1500.00 to 5000.00) but it will also allow us to receive support for any problems associated with the software. Because the Storage Area Network, Blade Servers, and associated hardware are very specific and unique, Hewlett and Packard will not sell the system unless a Hewlett and Packard certified technician installs and sets it up. There are no third party vendors that will help with any software related questions.

Additionally as referenced, there is an annual reoccurring cost of approximately \$7,000 in maintenance support that will be budgeted in future fiscal years from the MIS budget of the General Fund.
