

SUMMARY STATEMENT This resolution is part of the administration's annual effort to secure state funding for City capital projects and operating cost. The Planning Commission adopted Resolution Serial N0. 12-18(AM) in support of the following capital projects in accordance with WMC 2.60(A):

Sewage Treatment Plant Improvements

\$3 million

This funding is for new drainfields and other improvements at the sewage treatment plant to bring it into compliance with its discharge permit and allow for future growth in the community in the short term while a regional sewage treatment plant is planned for the greater Wasilla Area in the long term.

Airport Runway Extension to 5,000 Feet (Phase 1)

\$5 million

This funding will be used to extend the Wasilla Airport Runway from 3,700 feet to 5,000 feet. The total cost for this project is \$15 million, and the project will be phased to include an extension of Taxiway B. This project will help the economic opportunities at the airport and support more jobs in the region.

New Wasilla Public Library Match

This funding will provide a 50 percent match to construct a 24,000 square foot public library adjacent to the Wasilla Middle School on property provided by the School District. Total project cost is \$14 million to replace the existing 8,000 square foot library built in 1978 that had over 97,000 patrons through the door last year. This project is currently under review with the Foraker Pre-development Program.

Gravel Road Paving

The City currently has approximately 28 miles of gravel road or about 45 percent of its roads unpaved. This funding will be used to continue with the City's gravel road paving program to reduce road maintenance costs and improve air quality to its residents. This funding will pave approximately 6 miles of gravel road in FY2014.

Emergency Response Preparedness

This funding will be used for the Menard Sports Center to improve the Sports Center's ability to function as an emergency shelter. This funding will be used for additional cooking equipment, electrical improvements and fuel storage to support emergency response vehicles and refrigeration vans by making power available throughout the parking lots. The funding will also be used for emergency generators and equipment for other critical facilities such as Iditarod Elementary School and City Hall, and to provide a food cache to be maintained by the City.

Mat-Su Youth Court Operating Funds

The Mat-Su Youth Court is a state-sanctioned court that operates in the Matanuska-Susitna Valley, Alaska, which deals with first-time juvenile offenders that have committed misdemeanors. A three-judge panel hands down sentences consisting of community work service hours, an essay, and other sanctions, such as a letter of apology, viewing an adult arraignment, a tour of the Mat-Su Pretrial Facility, a drug/alcohol assessment, or a Juvenile Anti-Shoplifting class.
