  - 1. Reported that 70,000 yards of material per day have been moved to the haul road and to the disposal area on the south portion of the runway.
  - 2. Informed the commission that the AWOS project has a few issues and remains in service.
  - 3. Assured the Commission when the new down time for the AWOS is confirmed, it will be announced.
  - 4. Announced the Taxi way Alpha is closed and traffic is channeled through traffic way Delta.
  - 5. Reported that the dirt strip will be constructed this year but may not be seeded.
  - 6. Reported that the utilities will be bored under the runway.
