**City of Wasilla  
Ordinance Serial No. 13-13**

**An ordinance of the Wasilla City Council amending Wasilla Municipal Code (WMC) Subsection 12.24.015, in Chapter 12.24, Parks and Recreational Facilities, to add Lake Lucile Park to the list of parks managed or administered by the City of Wasilla.**

Section 1. Classification. This ordinance is of a general and permanent nature and shall become part of the city code.

Section 2. Amending WMC 12.24.015, Definitions, is hereby amended to read as follows:

When used in this chapter, the following words or phrases shall have the meanings set forth in this section:

*CAMP.* ~~“Camp” means a~~ Using an outdoor area or motor vehicle for sleeping or temporary living quarters, including without limitation erecting a tent or other temporary shelter.

*FIREARM.* ~~“Firearm” means a~~ A weapon, including a pistol, revolver, rifle, or shotgun, whether loaded or unloaded, operable or inoperable, designed for discharging a shot capable of causing death or serious physical injury.

*PARK.* ~~“Park” means e~~ Each of the following park or recreation areas managed or administered by the city:

1. Bumpus Recreation Area;
2. Carter Park;
3. Iditapark;
4. Lake Lucille Boat Launch;
5. Newcomb Park, including the adjacent swimming area in Wasilla Lake;
6. Nunley Park; ~~and~~
7. Curtis D. Menard Memorial Sports Center ~~Wasilla Multi Use Sports Complex;~~

and

8. Lake Lucile Park.


Section 4. Effective date. This ordinance shall take effect upon adoption by the Wasilla City Council.



**Summary Statement:** The City has been operating Lake Lucile Park for 3 years under a management agreement with the Matanuska-Susitna Borough in anticipation of the Borough transferring ownership of the park to the City. This code ordinance is needed for the Borough to proceed with the transfer. Once this ordinance is adopted by the City, the Borough will proceed with an ordinance delegating park powers to the City for Lake Lucile Park specifically.

This ordinance also updates the definition format and name of the Curtis D. Menard Memorial Sports Center in the code.
