Meta Rose Square: There are two methods for property disposal of public land as defined by Wasilla Municipal Code 5.32.040. The property can be sold by negotiated sale or exchange as provided in Section 5.32.100, or it can be sold by public auction or sealed bid. There are currently no conditions present to qualify for a negotiated sale or exchange as defined by 5.32.100. If the property is to be sold, then the administration proposes it be done through a sealed bid process.

Wasilla Municipal Code 5.32.030 states that no land shall be sold or exchanged for less than the approved minimum appraised or assessed value. The current assessed value is in the amount of \$1,867,400. Wasilla Municipal Code 5.32.060 states that the sale of any city land shall be approved by the council by ordinance after consideration of the recommendations of the planning commission. The proposed sale of the Meta Rose Square is being presented to the planning commission on July 9, 2013 for their recommendations.

Menard Sports Center Management Services Contract: A Request for Information was advertised on March 14, 2013 to seek individuals or companies interested in managing the Menard Sports Center. The deadline for proposals was May 16, 2013. No proposals were received.
