Summary Statement: On May 03, 2013 the City of Wasilla issued an Invitation to Bid, ITB 0503-0-2013/AD for Solid Waste Disposal Services. The services include container rental and ancillary equipment, refuse collection, refuse delivery to a State of Alaska Department of Environmental Conservation (SOA-DEC) approved site and the necessary permits/licenses to provide refuse services.

Dump fees are billed monthly and are based on tonnage when weighed at the landfill. This fee is a straight pass-thru billing based on the Mat-Su Borough's current rate of \$72/ton and is not included in the above calculation.

Two (2) bids were received. After review of the bids received from Red Box Refuse and Alaska Waste it is recommended that the City award a three (3) year contract to Red Box Refuse beginning July 1, 2013 through June 30, 2016.
