An ordinance of the Wasilla City Council amending the Fiscal Year 2014 Budget by appropriating \$25,000 in grant funds from the Alaska Mental Health Trust Authority and the Mat-Su Health Foundation for Newcomb Park Inclusive Playground.

Section 1. Classification. This is a non-code ordinance.

Section 2. Purpose. To amend the FY2014 budget by appropriating grant funding in the amount of \$15,000 from the Alaska Mental Health Trust Authority and in the amount of \$10,000 from the Mat-Su Health Foundation for an inclusive playground at Newcomb Park.

Section 3. Appropriation of Funds. The funds are appropriated to the following:
