Summary Statement: This project was advertised on August 1, 2013 for a bid opening on August 22, 2013 through ITB No. 0801-0-2013/AG. The attached recommendation of award shows Dirtworks, Inc. of Palmer as the responsive low bidder. This project is being awarded with the additive alternate to extend the 16-inch municipal water line from the Menard Center approximately 1 mile to the airport entrance with fire hydrants being placed along the new access road.

We have reviewed the bids submitted for the above-referenced project and have noted the following bid irregularities:

- > Dirtworks did not carry \$0.05 from Schedule A through to their Total Bid. Their bid as-submitted was \$1,094,807.00 and it should have read \$1,094,807.05.
- Scoggin Excavating had several errors in their bid. The item total for B-1 showed \$2,287.63 when it should have read \$2,282.60, B-2 showed \$152,112.50 when it should have read \$152,116.10. They also had an error on their summary page, the net total of their written numbers should have added up to \$1,365,245.73, however, they wrote \$1,365,245.72. The net result of these changes was a reduction of \$1.42 in their total hid price

The corrected bids are summarized below:

>	Central Environmental had a multiplication error on Item B-1. The item total . showed \$1,484,437.40 when it should have read \$1,423,837.40. This resulted in a net reduction of \$60,600 in their total bid price.
