## City of Wasilla Ordinance Serial No. 13-29

An ordinance of the Wasilla City Council confirming the assessment roll for the Lake Side Terrace P.U.D. Sewer Connection Special Assessment District for providing for the levy and payment of the assessment and providing for the payment of the Payment in Lieu of Assessment (PILA), and establishing the method for terminating assessments.

WHEREAS, the City Council on December 10, 2012, adopted Ordinance Serial No. 12-39 creating the Lake Side Terrace P.U.D. Sewer Connection Special Assessment District (the "District") and authorized the City to proceed with the improvement for 16 benefited properties; and

WHEREAS, upon favorable adoption of the improvement by the Lakeside Terrace Townhouse Association, \$1,000 non-refundable fee was provided to the City to move forward with the administration of the District (76 lots/units) and the PILA (16 lot/units); and

WHEREAS, the City Council on July 8, 2013, adopted Ordinance Serial No. 13-17 by creating the Lake Side Terrace P.U.D. Sewer Connection Special Assessment District (the "District") and authorized the City to proceed with the improvement to provide: city sewer service to 16 condominium units, create a PILA, and in addition create an assessment district for 76 units to be assessed individually for the project; and

WHEREAS, the City Council on July 8, 2013, adopted Ordinance Serial No. 13-17 which appropriated \$86,732 for the district improvements; and

WHEREAS, the City Council on August 12, 2013, adopted Action Memorandum No. 13-27 that approved the contract award to Scoggin Excavating in the amount of \$86,732 for the Lake Side Terrace Sewer Extension; and

WHEREAS, the District special assessment roll for lots described in Exhibit A has been prepared and the total costs of the improvement is now known to be \$90,929.44 and is spread equally among all the benefited properties within the District; and

WHEREAS, the PILA includes the properties described in Exhibit A, and the cost has been confirmed and is known to be \$800 per unit/lot and in addition a connection fee of \$260 per unit/lot; and

WHEREAS, the City Clerk has published a notice of the filing of the assessment roll once in the Frontiersman newspaper on October 18, 2013 stating that such assessment has been

made and is on file in the Office of the City Clerk, and providing notice of the time and place for the public hearing held by the City Council on October 28, 2013, where objections would be heard; and

WHEREAS, the City Council on October 28, 2013, held a hearing on the assessment roll at which time all persons objecting to assessments were given an opportunity to present their objections; and

WHEREAS, on October 15, 2013, notice of the assessment and hearing was mailed by the Finance Director to each owner of record of the District as shown on the property tax roll of the Matanuska-Susitna Borough Assessor; and

WHEREAS, the City Council found no errors or inequalities in the assessment roll for the District; and

WHEREAS, the City Council finds that the assessment roll for the District should be confirmed; and

WHEREAS, the sewer extension and connections have been constructed (the "Project"); and

WHEREAS, special assessments will be levied on properties in the District (76 units and/or lots) that are specially benefited by the Project, and said special assessments, with interest, will be sufficient and available to pay the actual cost to the city of the improvements plus interest; and

WHEREAS, in addition, a PILA will be levied on the 16 properties in the District that are specially benefited by the Project, and said PILA with administrative fee will be sufficient and available to pay the actual cost to the city of the improvements without interest.

## **Section 1. Classification.** This is a non-code ordinance.

- **Section 2. Confirmation of Roll.** That the assessment roll for Lake Side Terrace P.U.D. Sewer Connection Special Assessment District, attached as Exhibit A to this ordinance, as presented to the council on October 28, 2013 in the total amount of \$90,929.44 is confirmed.
- **Section 3. Confirmation of PILA.** The PILA for Lake Side Terrace P.U.D. Sewer Connection Special Assessment District, attached as Exhibit B to this ordinance, as presented to the council on October 28, 2013 in the total amount of \$1,060 per unit/lot (\$800 per unit/lot and a connection fee of \$260 per unit/lot), for a total amount of \$16,960.
- **Section 4. Notice of Assessment.** That within 15 days after the enactment date of this ordinance, the Finance Director shall mail to the record owner of each property assessed a statement designating the property, the assessment amount, the schedule of payments, the time of delinquency, and penalties. Within five days after the statements are mailed, the Finance Director shall publish a notice that the statements have been mailed and that the assessment roll

is on file in the Office of the City Clerk. After enactment of this ordinance the Finance Director shall file in the office of the Palmer District Recorder a notice of assessment (a lien) on all units/parcels assessed within the special assessment district.

**Section 5. Payment of Assessment.** That the entire assessment may be prepaid without interest or penalty within 30 days of the date of mailing of the assessment statement. Thereafter, the assessment may be prepaid in whole or in part with interest to the payment date. Interest on the unpaid amount of the assessment shall accrue at the rate of 5.25% per annum. Assessments that are not prepaid shall be paid in 10 equal annual installments on March 31, of each year, commencing March 31, 2014. Installments shall include principal plus accrued interest.

**Section 6. Payment of PILA.** The entire PILA may be prepaid without interest or penalty within 30 days of the date of mailing of the PILA statement. Thereafter, the PILA may be prepaid in whole or in part with interest to the payment date. The interest on the unpaid amount of the PILA shall accrue at the rate of 5.00% per annum. PILA's that are not prepaid shall be paid in 96 equal monthly installments, commencing December 1, 2013. Installments shall include principal plus accrued interest.

**Section 7. Delinquencies.** If an installment of the PILA or assessment is delinquent, the balance of the assessment or PILA, plus accrued interest, becomes due and delinquent 30 days after the date of notice of the installment delinquency. Notice of the delinquency shall be mailed to the owner of record. The notice must contain notice of the nonpayment of the installment and that the balance of the assessment or PILA, plus accrued interest, will become due and delinquent if the installment, interest and penalty are not paid within 30 days of the date of the notice. The penalty for delinquent installments, PILA or assessment payments is 5.00% per month, on the principal portion of required installment, from the date of delinquency.

**Section 8. Termination of Assessment.** Upon discharge of all indebtedness to the city, all liens placed upon units/parcels will be released. That for any lot upon which foreclosure proceedings to recover delinquent assessment installments has been commenced prior any liens will remain in force until payment to the city has been recovered including all principal, interest, penalty, fees or direct costs of foreclosure.

**Section 9. Effective date.** This ordinance shall take effect upon adoption by the Wasilla City Council.
