Summary Statement: During the FY2014 Budget process, the Sexual Assault Response Team (SART) program was discussed and \$2,500 appropriated within the WPD Administrative Division 001-4210-420-30-34.

The Mat-Su Borough Assembly agreed to fund \$190,565 through a planning block grant, which specifies that this grant can be used "for any planning, zoning, land use or other measures to further the goals of the Wasilla Comprehensive Plan". The City of Wasilla will use this funding as revenue offset to the FY2014 planning department where a total of \$295,747 was appropriated during the FY2014 Adopted Budget process and within Ordinance Serial No. 13-11(AM).

The City further needs to appropriate \$190,565 from the General Fund, Fund Balance to the Non-Departmental Budget as a pass thru to nonprofit/Alaska Family Service for the Sexual Assault Response Team (SART) program. Funding for SART will benefit the victims of sexual assault and assist the police department in their investigations. Training for SART has already begun, with the team to be ready by the first of the year.

Staff Recommendation: Introduce and set for public hearing Ordinance Serial No. 13-30.
