**Summary Statement:** Due to the recent attrition in the position of Recreation and Cultural Services Director, this is a good time for the City Administration and City Council to get together to determine an appropriate course of action for this department.

While it is understood that there may be a need to hire staff for part-time management of the Menard Center in the interim as this course of action is laid out, this staff can be hired on a temporary basis utilizing funds from the Temporary Account No. 001-4570.457-10-20. As part of this ordinance, \$20,000 is being added to the temp wage account for the Menard Center for this purpose.

The intent of this ordinance is such that no permanent positions are created or filled prior to the proposed operations/management audit being completed or the alternative of the City Administration laying out a proposal to City Council.

Upon adoption of this ordinance, a code ordinance will be brought forward to eliminate the Recreation and Cultural Services Director's position in the Wasilla Municipal Code.
