

Summary Statement: In accordance with Ordinance Serial No. 12-22, a committee was formed through Action Memorandum No. 13-21 on June 24, 2013 to provide recommendations to the City Council on planning a celebration to commemorate the 40th anniversary of the City's incorporation. The committee is making the following recommendations for council consideration to celebrate the 40th anniversary.

Thursday, March 27, ²⁰¹⁴~~2013~~ provide a luncheon for all past and present Mayors and Council members with luncheon to be free and catered at the Menard Center.

Friday, March 28, ²⁰¹⁴~~2013~~ at the Menard Center provide a museum display on the mezzanine, open turf with kid's games, provide dance with a light show, catering (finger foods) and door prizes. Give away tie-dye tee-shirts, provide fireworks and establish a 40 year souvenir (to be determined).

Ordinance Serial No. 13-33 is proposed to provide funding for the recommended activities.
