Ordinance Serial No. 13-37**

An ordinance of the Wasilla City Council amending Wasilla Municipal Code 13.08.070(C), Sewer – Service Fees, to continue the current rate to be paid by customers.

Section 1. Classification. This ordinance is of a general and permanent nature and shall become part of the city code.

Section 2. Amendment of section. WMC 13.08.070(C), Sewer – Service Fees, is hereby amended to read as follows:

C. Monthly Sewer service shall be furnished at the following rates:

Sewer Service Monthly Rate	7/1/2013— 12/31/2013 Monthly Rate	1/1/2014— 6/30/2014
With water meter per 1,000 gallons	\$9.60	\$10.32
Without water meter	\$61.03	\$65.61
Minimum per month	\$47.98	\$51.58

Section 3. Effective date. This ordinance shall take effect upon adoption by the Wasilla City Council.

Summary Statement: Ordinance Serial No. 13-16(AM) was adopted by the Wasilla City Council on July 8, 2013, to amend the five-year sewer rate increase plan, as shown in WMC 13.08.070(C), and to utilize a General Fund transfer to cover the scheduled FY-2014 increase in water rates with a rate increase date of December 31, 2013.

The intent of this ordinance is to stop future rate increases and hold the current rate to give our residents and businesses economic relief from continuous increasing water rates.

Staff Recommendation: Introduce and set for public hearing Ordinance Serial No. 13-37. If adopted, an appropriation ordinance would be brought forward at a future Council meeting.
