Ordinance Serial No. 14-07**

An ordinance of the Wasilla City Council amending Wasilla Municipal Code (WMC) Chapters 1.20.030(C) Disposition of Scheduled Offenses—Fine Schedule, and 6.40.085(B) Violations-Remedies, regarding business licenses violations.

Section 1. Classification. This ordinance is of a general and permanent nature and shall become part of the city code.

Section 2. Amendment of subsection. WMC 1.20.030(C) Disposition of scheduled offenses – Fine schedule, in the General Penalty section, is hereby amended to add the following fine to the schedule, as follows:

CODE SECTION	DESCRIPTION OF OFFENSE	FINE
<u>WMC 6.04.085</u>	<u>Business License Violations</u>	<u>\$250</u>

Section 3. Amendment of subsection. WMC 6.04.085(B), Violations – Remedies, in the Business Licenses Generally Chapter, is hereby amended to read as follows:

(B) A person who is convicted of violating a provision of this subsection shall be subject to a fine of not more than \$250~~300~~.

Section 4. Effective date. This ordinance shall take effect upon adoption by the Wasilla City Council.




Summary Statement: Several months ago Council adopted Ordinance Serial No. 13-23 which updated the Wasilla Municipal Code in regard to changing several general penalties and code sections.

In coordinating these many new code revisions with the Alaska State Court System, we found two minor errors which need to be updated in the code.

Ordinance Serial No. 14-07 amends the fine schedule in WMC 1.20.030(C) and also changes the fine in WMC 6.04.085(B) from \$300 to \$250 for business licenses violations; this is the same fee as the business license required fine which is also \$250.

Staff Recommendation: Introduce and set for public hearing Ordinance Serial No. 14-07.
