Westpoint/West Cove Paving L.I.D.

The Administration has received indications of interest from property owners served by Westpoint and West Cove Drives connecting Crusey Street and Lakeshore Drive. The proposed strip paving would serve the Wasilla Professional Building, Romar Center and residential development along Wasilla Lake. Westpoint/West Cove would provide a third alternate access to the south entrance of the West Valley Medical Campus.

Preliminary engineering cost estimates have been prepared by Mike Erdman, P.E. indicating a total project cost of \$215,000. Under the present policy, 1/3 or \$71,667 would be paid by benefited properties under a paving local improvement district and 2/3 or \$143,330 would be paid from sales tax or state grant funds, subject to availability of funds.

Administration respectfully requests that Council authorize a formal survey of owners and development of a proposed local improvement district to pave Westpoint and West Cove Drives from Crusey Street to Lakeshore Drive.


