City of Wasilla Ordinance Serial No. 14-19

An ordinance of the Wasilla City Council amending Wasilla Municipal Code (WMC) 10.20.050.B, Unauthorized Use of Parking Reserved for Persons with Disabilities, relating to general penalties.

Section 1. Classification. This ordinance is of a general and permanent nature and shall become part of the city code.

Section 2. Amendment of section. WMC 10.20.050.B, Unauthorized Use of Parking Reserved for Persons with Disabilities, is hereby amended to read as follows:

B. A person who violates this section is guilty of an infraction. Upon conviction, the court shall impose a fine of not less than \$125, or, if the person has been previously convicted under this section, <u>**pay**</u> the court shall impose a fine of not less than \$250.

Section 3. Effective date. This ordinance shall take effect upon adoption by the Wasilla City Council.
