SUMMARY STATEMENT: The City of Wasilla Police Department wishes to amend the FY-08 Police Department budget by \$62,500 to accept the federal forfeiture funds from the State of Alaska, Department of Public Safety, Division of Alaska State Troopers, Alaska Bureau of Alcohol and Drug Enforcement.

The primary purpose of the Department of Justice's forfeiture program is Law Enforcement. Federal forfeiture funds are closely regulated and must conform to the permissible uses of shared funds.

The expenditures targeted with this funding will allow for the purchase of an unmarked vehicle for use in the investigations unit--\$29,500, equipment to further enhance the investigation of fraud and forgery--\$15,000, certification training for the canine unit--\$8,500, and equipment to be used for firearms training and maintenance of the firearms inventory--\$9,500.

Staff Recommendation:

Amend the FY-08 Police budget by accepting and appropriating from the State of Alaska, Department of Public Safety, Division of Alaska State Troopers, Alaska Bureau of Alcohol and Drug Enforcement in the amount of \$62,500.
