**Summary Statement:** This ordinance is proposed to amend the fiscal year 2014 budget by appropriating \$76,000 from the water fund for water main extensions by private developers oversizing costs, when the City requires oversizing of the water system by the private developer. The public works department is currently working with 2 developers this construction season where oversizing funding will be needed:

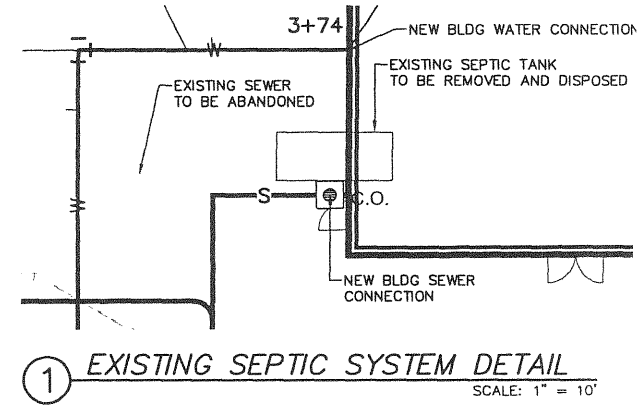
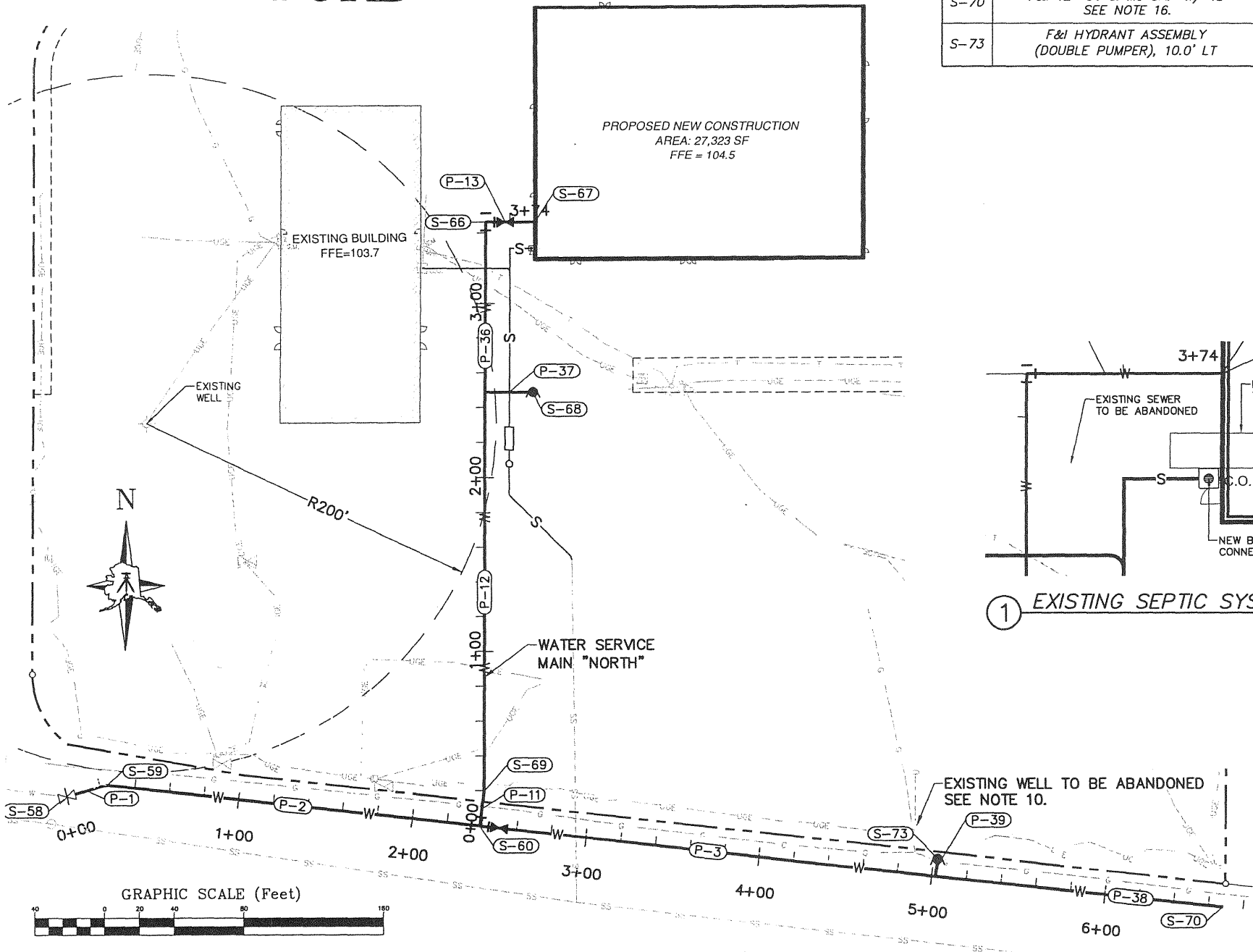
- 1) Kendal Ford is extending the City's water main along E. Sun Mountain Avenue for a new maintenance facility and they are being required to install larger diameter pipe for improved fire flow, and they are being required to extend the line an additional 200 feet to complete a loop of the water system in that area. The addition costs for this work is approximately \$52,000; and
- 2) JYG Investment Group, LLC is extending the City's water main from the Richmond Hills Booster Station to serve a Planned Unit Development of sixteen four-plexes along Old Matanuska Road and they are being required to install larger diameter pipe for improved fire flow. The additional cost for this work is approximately \$24,000.

Actions Memorandums will be presented for City council approval to authorize these expenditures separately at a later date.
