

Summary Statement: This action memorandum authorizes the administration to proceed with engineering and bidding the paving of twelve (12) roads for work this construction season. The attached road matrix was prepared by Lounsbury & Associates to prioritize approximately 3 miles of roads that can be paved based their current condition. The roads with the lower ready factor require additional excavation to improve width and/or drainage that will occur over the next 3-5 years to make them ready for future paving.

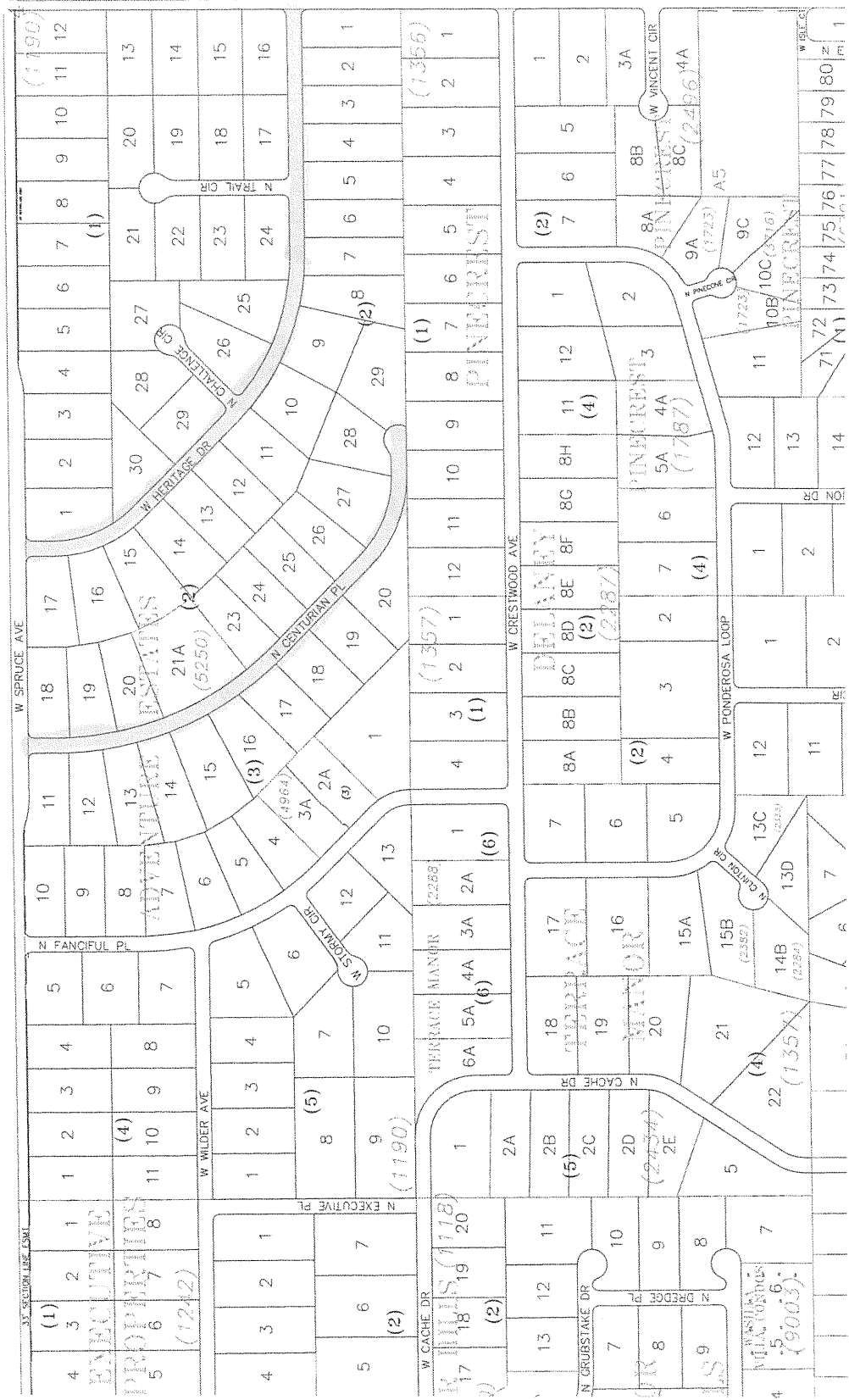
A separate action memorandum will be presented for City Council approval once the project has been bid and a contract award can be authorized with the actual cost included.

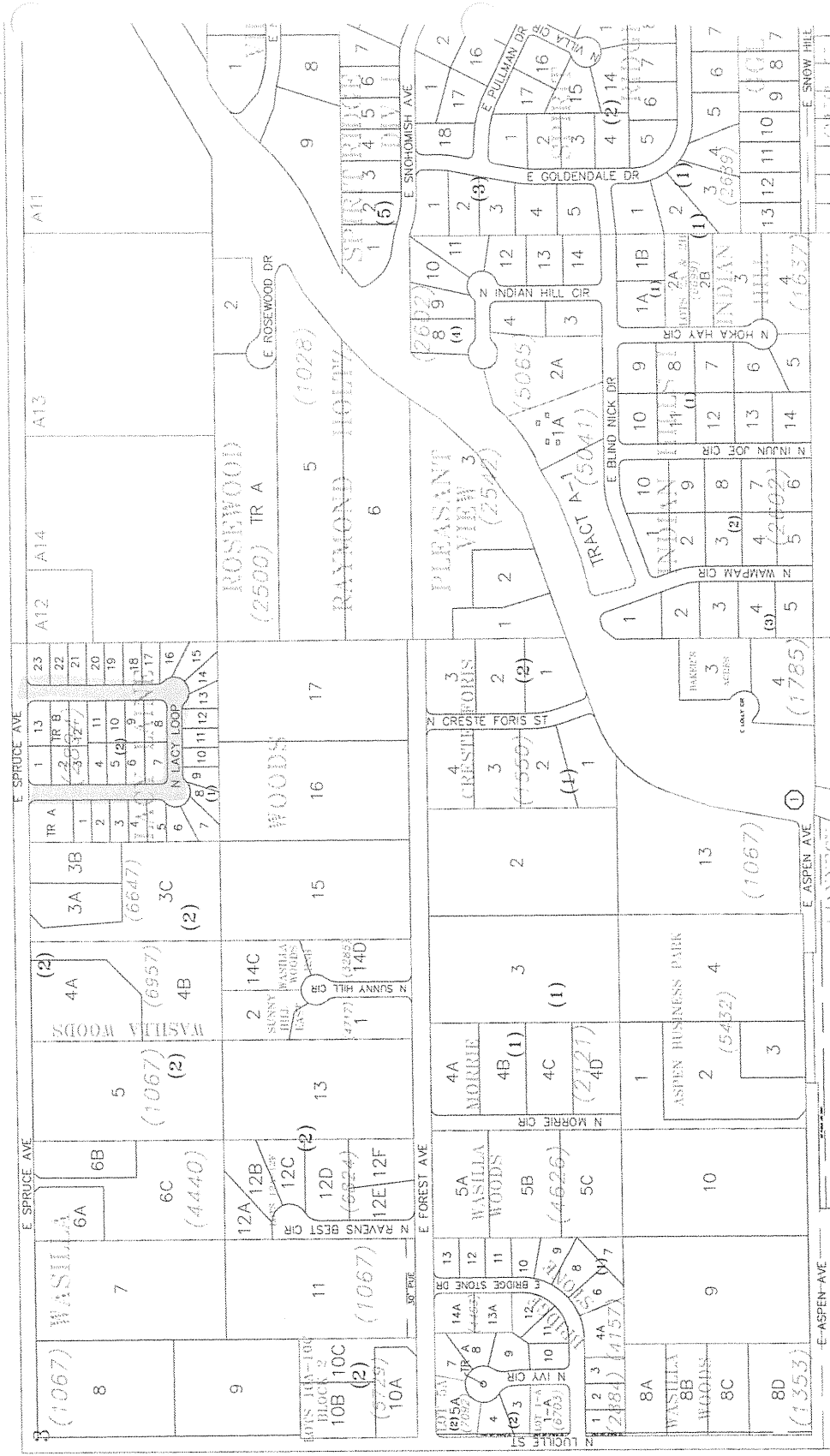
