Summary Statement: The owner of Farina's Restaurant Supply company made an inquiry with the City and ADOT in May with respect to the possibility of extending the City water system to their property. The administration followed up with a preliminary design and confirmed that an 8-inch water line could be extended from Lucus Road to Farina's property and benefit other properties in the area.

ADOT provided an order of magnitude estimate from the contractor working the Parks Highway project in the amount of \$60,000. This work is eligible for an LID and the project is feasible. ADOT is currently confirming if the work can be done this year as part of the Parks Highway project. If ADOT agrees the work can be done as part of the project, then an ordinance would come forward for City Council approval to establish a Limited Improvement District for this water line extension.
